**Introduction**

The *Access to Information Act* gives Canadian citizens as well as people and corporations present in Canada the right to have access to federal government records that are not of a personal nature. The Act complements but does not replace other procedures for obtaining government information. It is not intended to limit in any way the access to government information that is normally available to the public upon request.

In accordance with the provisions of section 72 of the Act, Parc Downsview Park Inc. (PDP) has prepared its annual report on the administration of this act and the annual report will be tabled in Parliament.

**Mandate of Parc Downsview Park Inc.**

PDP is an agent Crown corporation and a wholly-owned subsidiary of Canada Lands Company Limited.

PDP was incorporated in 1998 to manage and develop the former Canadian Forces Base Toronto lands.

**Activities Regarding the *Access to Information Act***

All responsibilities regarding the administration of the *Access to Information Act* rest upon the Corporate Secretary who reports directly to the President and Chief Executive Officer. The latter is the head of the government institution for the purpose of the Act and he delegated all his powers under the Act to the Corporate Secretary. A copy of the delegation order is enclosed at the end of this report.

**Introduction**

*La Loi sur l'accès à l'information* donne aux citoyens canadiens ainsi qu'aux personnes et sociétés présentes au Canada le droit d'accès aux dossiers du gouvernement fédéral qui ne contiennent pas de renseignements personnels. La Loi complète plutôt qu'elle ne remplace les autres procédures d'obtention des renseignements gouvernementaux. Elle ne place aucune limite sur les autres méthodes d'accès sur demande auxquelles le grand public peut habituellement avoir recours.

Conformément aux dispositions de l'article 72 de la Loi, Parc Downsview Park Inc. (PDP) a préparé son rapport annuel sur l'administration de cette loi et le rapport annuel sera déposé au Parlement.

**Mandat de Parc Downsview Park Inc.**

PDP est une société d'État, filiale à part entière de la Société immobilière du Canada limitée.

PDP a été constituée en 1998 pour gérer et aménager l'ancienne base des Forces canadiennes Toronto.

**Activités relatives à *Loi sur l'accès à l'information***

Toutes les responsabilités liées à la *Loi sur l'accès à l'information* incombent au Secrétaire général qui relève directement du Président et directeur général de l'institution. Ce dernier, étant responsable de l'institution fédérale aux fins de la Loi, lui a délégué tous les pouvoirs en vertu de l'ordonnance de délégation. Une copie du décret de délégation de pouvoirs est jointe à ce rapport.

A law clerk is assisting the Corporate Secretary in managing access to information activities.

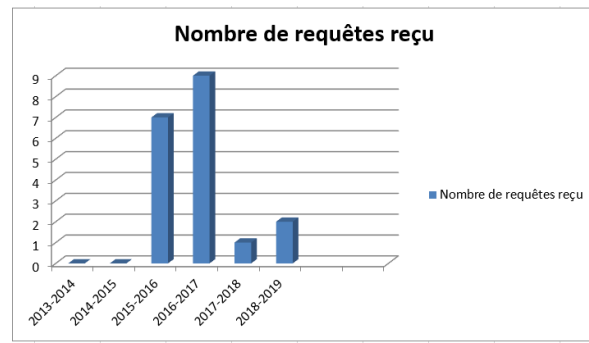
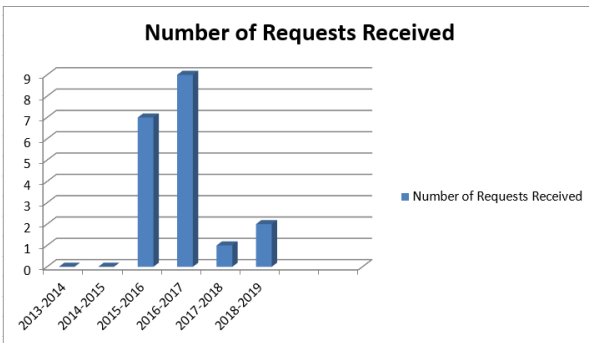
### Rapport statistique
